


#### The employed population by the types of economic activity in 2014







#### **Gross agricultural product**






#### **Export of agricultural products**




#### Fixed capital investments in agriculture






#### Kazakhstan takes the 9<sup>th</sup> place in the world by territory






## **Increase of agricultural land usage lease terms for foreign companies from 10 to 25 years**



#### Removing restrictions on turnover of agricultural land

- Simplification of procedures and conditions for the acquisition of agricultural land in private ownership;
- Removing the restrictions on land transactions in the secondary market;
- Simplification of the procedures for changing the category of land;
- Simplification of the procedures for transferring the land into mortgage;
- Shortening the registration of transactions with land.

The transition from the authorization status of the State register of breeding achievements to the recommendation status.





#### + Advantages of automation

- 1. Minimizing contact between the service provider and customer;
- 2. Speeding up the process of obtaining subsidies;
- 3. Increasing the transparency of the process of obtaining a subsidy.



#### Draft Law "On Agricultural Cooperation"

- 1. Lifting the prohibition on the distribution of profits;
- 2. One law instead of five;
- 3. Special tax regime for agricultural cooperatives;
- 4. Subsidizing the cost of the audit of agricultural cooperatives.
